

# FIRE PREVENTION AND LIFE SAFETY REPORT

When it is time for spring cleaning, remember a clean house is a safer house. The Fire Prevention Bureau suggests that you take a few moments to check some areas in your house for hazards that could cause a fire.

#### LIVING OR FAMILY ROOM

- Eliminate overloaded electrical outlets.
- Minimize the number and length of extension cords.
- Allow space around the TV and stereo equipment to prevent overheating.
- Use a metal screen in front of the fireplace.
- Have large, deep ashtrays for smokers and make sure all smoking materials have been extinguished before disposal.

#### **KITCHEN**

- Keep surfaces clean and free of grease.
- Do not leave the kitchen while the stove or oven is in use. Many fires begin during unattended cooking.
- Turn pot handles in so they cannot be knocked off or pulled down by small children.
- If you have a grease fire, put a lid on it! Using water will spread the fire.

#### **BEDROOMS**

- Make a firm rule not to allow anyone to smoke in bed.
- Working smoke detectors should be installed outside each sleeping area. Test the detectors monthly and change the batteries twice a year.
- Have a home fire escape plan and practice it with your family.

#### **BASEMENTS, GARAGE AND STORAGE AREAS**

- Have the furnace, wood or coal burning stoves or any other heating appliance inspected by a professional prior to each heating season.
- Keep areas around heating equipment free of papers, rags or flammable liquids.
- Store gasoline or other flammable liquids in safety cans outside your home.

#### **THROUGHOUT THE HOUSE**

- Keep matches and lighters stored where children cannot find them.
- Post Emergency numbers on all phones.
- Do not let papers or trash accumulate.
- Unplug appliances when not in use.

It only takes a few minutes to check your home for fire hazards. You could be preventing a fire and possibly saving a life . . . the life of your family.

#### IN CASE OF FIRE - BE PREPARED

Recognizing the possibility that fire may strike your home, decide now how you would be able to save your family's lives were you to awake and smell smoke tonight!

Plan two possible routes to the ground from any upstairs bedroom. It is unlikely that both escape routes would be cutoff by flames during the early stage of fire. We recommend that every home with children conduct regular home fire drills, showing the children where to go and what to do if the normal escape route is blocked by fire.

#### If Fire Starts:

- 1. Arouse everyone in the house. Make it your first duty to get everyone out of the house.
- 2. Call the Fire Department at once.
  - (a) Have number posted near phone. 9-1-1
  - (b) Know location of nearest Fire Alarm Box.

#### If Trapped on 2nd or Upper Floors:

- 3. Jump only as a last resort.
- 4. Close door leading to hall.
- 5. Keep low, on hands and knees crawl to window.
- 6. Open window, top and bottom, place head out window and wait for help.
- 7. Use porch roof if possible.

# **ESCAPE RULES**

- 1. Keep close to the floor.
- 2. Take short breaths and cover face with wet cloth.
- 3. Keep out of excessive heat and smoke. Feel doors, if hot don't open.
- 4. Have outside gathering point. Is everyone out?
- 5. Never re-enter the burning building.

# DARTMOUTH FIRE DISTRICT NO. 1 ANNUAL DISTRICT MEETING MAY 14, 2001

Pursuant to a Warrant duly issued by the Prudential Committee of the District, the Annual Meeting of the District was held on Monday, May 14, 2001. The Meeting was called to order by the District Clerk at 6:48 P.M. who declared that 35 registered voters being present and that 35 comprise a quorum, a quorum in fact was present. Additional voters arrived after the meeting commenced totaling 36.

The Clerk noted that the Warrant was posted in accordance with the By-Laws of the District in the several locations throughout the District as well as in the Chronicle on April 26, 2001.

A Pledge of Allegiance to the Flag and a moment of silence for those of the District who have died since our last meeting.

The Clerk noted that all appropriations for the meeting would be raised from the Tax Levy unless otherwise stated in the motion.

The District Clerk then took up action on Article 1 of the Warrant.

**ARTICLE 1:** To choose a Moderator for the ensuing year.

MOVED and seconded to elect Randall Weeks to the position of Moderator

MOVED, seconded and unanimously voted to close nominations for the position of Moderator.

Comes now the vote on the main motion.

VOTED unanimously at 6:51 P.M.

The Moderator was sworn to the faithful performance of his duties, and took over the meeting.

**ARTICLE 2:** To see if the District will vote to compensate firefighters at the rate of \$17.00 per hour for toned incidents and \$15.00 per hour for details, maintenance, snorkel and garage duty. Unchanged from last year.

MOVED, seconded and unanimously voted at 6:55 P.M. that the District compensate firefighters at the rate of \$17.00 per hour for toned incidents and \$15.00 per hour for details, maintenance, snorkel and garage duty.

ARTICLE 3: To see if the District will vote to raise and appropriate the sum of \$290,000. for the SUPPORT OF THE DISTRICT. The fiscal year 2001 appropriation was \$260,000.

MOVED, seconded and unanimously voted at 6:56 P.M. that the District raise and appropriate the sum of \$290,000. for the SUPPORT OF THE DISTRICT.

**ARTICLE 4:** To see if the District will vote to raise and appropriate the sum of \$5,000. for TRAVEL AND TRAINING.

The fiscal year 2001 appropriation was included in the Support of the District Account.

MOVED, seconded and voted at 7:00 P.M. that the District raise and appropriate the sum of \$5,000. for TRAVEL AND TRAINING.

**ARTICLE 5:** To see if the District will vote to fix the salaries of the several District Officers, the Assessors, and the Tax Collector for the fiscal year beginning July 1, 2001 and to appropriate a sum of money therefore.

MOVED, seconded and unanimously voted at 7:04 P.M. that the District raise and appropriate the sum of \$40,000. for the BUILDING ACCOUNT for maintenance and running expenses of

ARTICLE 7: To see if the District will vote to authorize the Board of Engineers, with the approval of the Prudential Committee, to sell or otherwise dispose of any surplus equipment belonging to the District. This article is an annual request.

MOVED, seconded and unanimously voted at 7:05 P.M. that the District authorize the Board of Engineers, with the approval of the Prudential Committee, to sell or otherwise dispose of any surplus equipment belonging to the District.

ARTICLE 8: To see if the District will vote to appropriate the sum of \$20,000. by transfer from SURPLUS REVENUE (FREE CASH) for the RESERVE FUND. The Reserve Fund is utilized for extraordinary and unforeseen expenditures. The unencumbered balance will revert back to Surplus Revenue at the end of the fiscal year.

MOVED, seconded and unanimously voted at 7:06 P.M. that the District appropriate the sum of \$20,000. by transfer from SURPLUS REVENUE (FREE CASH) for the RESERVE FUND.

**ARTICLE 9:** To see if the District will vote to raise and appropriate a sum of money for the following specific purposes:

A:	Thermal Imaging Upgrades	\$ 9,000.
B:	Building Generator	\$13,000.
C.	Upgrade SCBA	\$10,000.
D:	Six Portable Radios	\$ 5,000.
E:	Replace Existing Pavement	\$23,000.

MOVED, seconded and unanimously voted at 7:07 P.M. that the District raise and appropriate \$60,000. for the following specific purposes:

ARTICLE 10: To see if the District will vote to appropriate the sum of \$35,500 by transfer from SURPLUS REVENUE (FREE CASH) for a fully equipped DISTRICT UTILITY VEHICLE. This vehicle will replace the District's 1994 Ford Explorer. Specifications for the new vehicle shall be available at the engine house. The existing utility vehicle will be taken in-trade by the successful bidder.

MOVED, seconded and unanimously voted at 7:08 P.M. that the District appropriate the sum of \$35,500 by transfer from SURPLUS REVENUE (FREE CASH) for a fully equipped DISTRICT UTILITY VEHICLE.

#### ARTICLE 11: To see if the District will vote to establish a By-Laws Study Committee.

The committee will be responsible for reviewing the existing District By-Laws and returning their recommendations to the Prudential Committee by February 1, 2002.

MOVED, and seconded that the District establish a By-Laws Study Committee.

Discussion ensued.

MOVED, and seconded to amend the main motion to read as follows. The District shall establish a five member By-Laws Study Committee. The Committee shall have a minimum of 3 non firefighters.

Motion passed.

Comes now the vote on the main motion.

VOTED as amended at 7:15 P.M.

**ARTICLE 12:** To see if the District will vote to amend Article II, Section 3 of the By-Laws in regards to vacancies of the Board of Engineers, Prudential Committee, Treasurer, Clerk, and Auditors to wit:

In the event of a vacancy in the office of Chief Engineer the First Assistant Engineer shall become Chief Engineer and the Second Assistant Engineer shall become First Assistant Engineer to serve until the next annual election. A vacancy in the office of the First Assistant Engineer shall be filled by the Second Assistant Engineer until the next annual election. A vacancy in the office of Second Assistant Engineer shall be filled by a majority vote at a joint convention of the Board of Engineers and the Prudential Committee if so requested by the Board of Engineers, said meeting to be called by the Prudential Committee within fourteen days after such request is made and the officer so chosen shall serve until the next annual election. If a vacancy occurs on the Prudential Committee, the remaining Prudential Committee members may call a special election and must do so upon the written request, filed at least one hundred days before the next annual election, of fifty registered District voters. Otherwise, the vacancy shall be filled at the next annual election for the remainder of the term. A special election for Prudential Committee may be called as soon as a resignation is filed with the District Clerk. The special election may not be held before the resignation's effective date. If the Treasurer is prevented from performing his official duties, or if the office is vacant, the Prudential Committee may in writing appoint a temporary Treasurer, who shall give bond in like manner as the Treasurer and shall hold his office until another is chosen. If the Clerk is prevented from performing his official duties, or if the office is vacant, the Prudential Committee may in writing appoint a temporary Clerk who shall hold his office until another is chosen. A vacancy in the office of Auditor shall be filled by a majority vote at a joint convention of the Auditors and the Prudential Committee if so requested by the Auditors, said meeting to be called by the Prudential Committee within fourteen days after such request is made and the officers so chosen shall serve until the next annual election.

MOVED, and seconded that the District amend Article II, Section 3 of the By-Laws in regards to vacancies of the Board of Engineers, Prudential Committee, Treasurer, Clerk, and Auditors as printed in the warrant.

Discussion ensued.

Motion to table Article 12 failed.

Motion to have the District Clerk and the remaining Prudential Committee members fill a vacancy on the Prudential Committee failed.

FAILED at 7:34 P.M.

**ARTICLE 13:** To see if the District will vote to amend Article IV, Section 9 of the By-Laws in regards to compensating the First and Second Assistant Engineers while performing the duties of the Chief Engineer.

The First Assistant Engineer or in his absence the Second Assistant Engineer shall be compensated in the absence of the Chief Engineer while performing the duties of Chief Engineer.

This shall only take place for periods extending longer than normal scheduled vacation, sickness, short term disability or subject to the discretion of the Prudential Committee or a combination thereof exceeding a two (2) week period.

This shall be done by means of an hourly schedule, at a rate of firefighter that is set forth in the current warrant, article scale of wages for firefighters. And all hours worked shall be submitted in writing, and shall be approved by the Prudential Committee.

This shall be combined with the First **or Second** Assistant Engineers salary, and the total shall not exceed that salary of the Chief Engineer, that is set from the current warrant, article scale of officer's salary.

MOVED, seconded and voted at 7:35 P.M. that the District amend Article IV, Section 9 of the By-Laws in regards to compensating the First and Second Assistant Engineers while performing the duties of the Chief Engineer as printed in the warrant.

**ARTICLE 14:** To see if the District will vote to appropriate the sum of \$12,500 by transfer from SURPLUS REVENUE (FREE CASH) for the purpose of equipping the Dartmouth Fire District No. 1 Dive Team.

MOVED, and seconded that the District appropriate the sum of \$12,500 by transfer from SURPLUS REVENUE (FREE CASH) for the purpose of equipping the Dartmouth Fire District No. 1 Dive Team.

Discussion ensued.

VOTED by a majority at 7:58 P.M.

There being no further business to come before the meeting it was: MOVED, seconded and unanimously voted that the meeting stand adjourned at 7:59 P.M.

We herewith submit our annual report for the year ending December 31, 2001.

The Prudential Committee, following the annual election, organized as follows:

During the year, regular monthly meetings were held, at which time business was transacted and bills approved. The committee approved all vouchers appearing on the treasury warrants.

Requests by the Board of Engineers for new equipment and repairs of present equipment were granted, in order to maintain the efficiency of the department.

The Prudential Committee, together with the Board of Engineers, continue to study the future needs of the District.

Over the course of the past year, the Prudential Committee has continued to improve and maintain the District Property.

In the spring, the interior walls of the meeting room were painted, as well as the basement stairway and lower hallway. Also, the carpet in the basement was removed and replaced.

During the summer months the original asphalt parking lot and apparatus apron was replace and improved to allow better access to the rear parking lot from Cleveland Street. While this project was underway, a concrete pad was placed under the storage container in the rear lot to prevent any damage to the new pavement.

In the fall, a new sink was purchased and installed in the kitchen, bringing the facility into compliance with current Board of Health requirements.

Additionally, a new back up generator was purchased and installed at the station. This new piece of equipment replaced the original building generator and is a more powerful unit, so as to allow for future expansion of the buildings emergency power system.

The Prudential Committee wishes to thank the officers and men of the District for their cooperation and assistance during this calendar year.

# **Board of Engineers Report**

The Board of Engineers is again is working hard to continue in the restructuring of the department. District One responded to twenty-six more calls this year than last year, due to the new policies that were implemented last year between all three-fire districts and the Police Department. The board once again is working hard to make sure there is a truck stationed on the west side of the bridge along with automatic response from District Two when the Padanaram Bridge is closed to motor vehicle traffic.

The fire prevention program has added another member to teach the S.A.F.E. program in our local schools. This year the S.A.F.E. program was awarded a \$ 2,000 grant. The program was able to purchase up to date National Fire Protection Association fire safety videos for the schools and daycare facilities.

All apparatus maintenance has been done in house or sent out for repair, so that the equipment can be kept in top running order. Once again the departments three aerial devices have been tested by American Test Center as required by National Fire Protection Association. The department's entire fleet has been sent out for their annual State and Department of Transportation inspections with no major problems found.

The department's newest vehicle, a 2001 Chevrolet Tahoe was delivered in late August and was put in service about two weeks after being delivered. The vehicle is equipped with multi channel radios and other needed equipment. It was quickly put to use during its first major call on September 13 for an automobile that had struck a 12,000-gallon gasoline tanker truck on Cove Road and Dartmouth Street. The incident commander was able to communicate with the multi agencies that had responded to assist.

Once again the Board of Engineers would like to thank all the firefighters for their outstanding job and cooperation in attending the departments drills and incidents that have occurred this year. We would also like to thank all the Districts residents for their continued support throughout the year.

Continuing with recent policy, regular meetings of the Training Committee are held on the last Sunday morning of each month. During 2001, the Training Committee was comprised of the following members.

During 2001, Firefighter Peter Andrade resigned his position as a member of the Training Committee. We thank him for his time and efforts during his two years of service.

Throughout 2001, bi-monthly drills have been conducted regularly on the first and third Wednesday evening of each month under the supervision of the department officers. The policy of conducting Friday morning drills has also continued to prove beneficial in accommodating those individuals unable to attend on Wednesday evenings. Overall training efforts have continued to focus on practical fireground applications, with emphasis on apparatus training and operations, particularly during the summer months.

During March, seven members of the department participated in various training classes conducted at the National Fire Academy in Emmitsburg, Maryland. In both June and November, department members participated in live burn training evolutions conducted at the Barnstable County Fire Academy training facility in Hyannis. These evolutions provided all participants with experience in practicing interior structural fire attack and extinguishment procedures under live fire conditions. As required by law, all firefighters have completed and are currently certified in both CPR and first responder first aid training.

At this time the members of the Training Committee would like to express their appreciation to the officers and firefighters for their continued cooperation and participation in department training programs throughout the past year, and ask their continued support and commitment as we continue our efforts to provide dedicated service and quality protection to all residents of the District.
